How to enter:

To be eligible for the AIST Trustee of the Year Award, candidates must be a current trustee director of a not-for-profit superannuation fund and a current member of AIST.

Current directors serving as directors on the AIST board up to the AIST AGM 2017 are not eligible to be nominated for this award.

Trustees may be nominated by their peers or fund CEO via the following nomination form.

Nominations should address the below criteria in no more than 1000 words and be received at AIST by Friday 3 February, 2017.

The AIST Trustee of the Year Award winner will be announced at CMSF 22 – 24 March, 2017.

Criteria:

Nominations of no more than 1000 words should detail why you think your nominated trustee director deserves this award by providing examples and addressing the relevant components from the criteria below:

- Contribution to the fund via board and governance activities
- Contribution to positive member outcomes
- Involvement in strategic planning and development
- Involvement in industry committees and working groups
- Involvement in greater community projects to advance the role of superannuation
- Alignment with fund's culture, values, vision and mission
- Demonstration of their capacity as a responsible fiduciary

Scholarship Award Terms and Conditions:

- The 2017 Trustee of the Year award winner:
 - Is eligible for attendance to the 2018 Global Dialogue only
 - Is not transferable to an alternate years Global Dialogue
 - Is not transferrable to another person or another event
 - Must be a current trustee director of a not-for-profit superannuation fund and a current member of AIST during the 2018 Global Dialogue dates (TBC May / June 2018).
- The 2017 Trustee of the Year award includes:
 - Conference Registration to the 2018 Global Dialogue
 - Accommodation for one person at the 2018 Global Dialogue hotel
 - Attendance at 2018 Global Dialogue associated social functions
 - Return economy airfares to and from any Australian Capital City to the 2018 Global Dialogue location.
- What is not included:
 - Travel insurance, transfers, extended travel or accommodation outside of the conference dates, partner program fees/travel and any incidental costs will be at the prize winners own expense.
- The scholarship is not able to be taken as cash.
